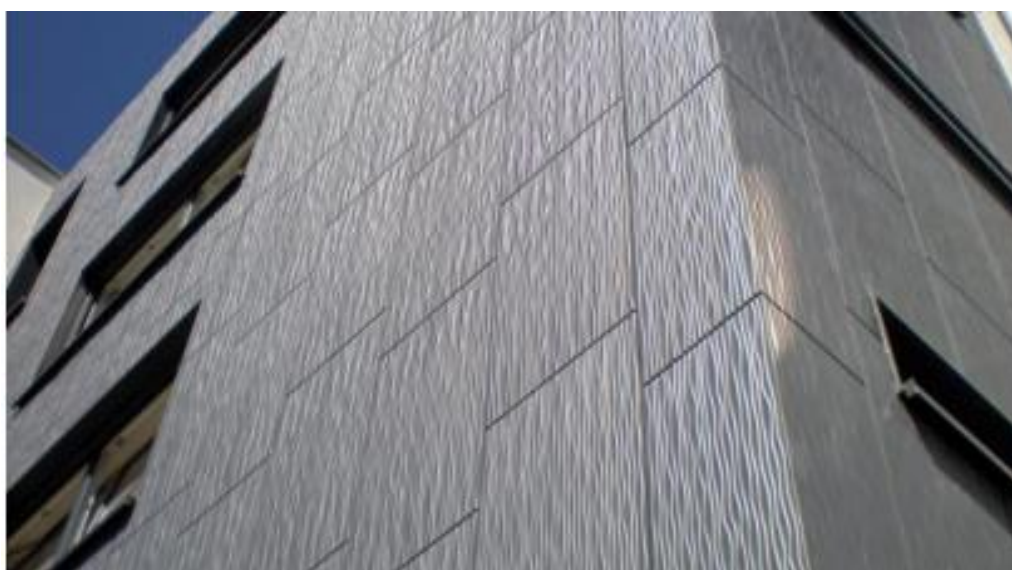

Product identification: Facade cladding slab in mineral composite. More information on the product can be found on www.carea-facade.com.

Product description: The product is a mineral composite panel mainly composed of mineral filler bound by a resin and shaped using press, a surface layer is added as product finish. Panels are fixed on the wall using screws, included in the EPD scope. The installation is also possible with understructure but not include in the EPD scope. See technical advice 2.2/11-1484_V2.

The product is intended to be installed on the exterior façade on every type of building, new or refurbished. See technical advice for more details.

Geographical scope: The products covered by this EPD are manufactured in France. They have been modelled to be representative of CAREA's export in Great Britain, Ireland, Switzerland and Germany.

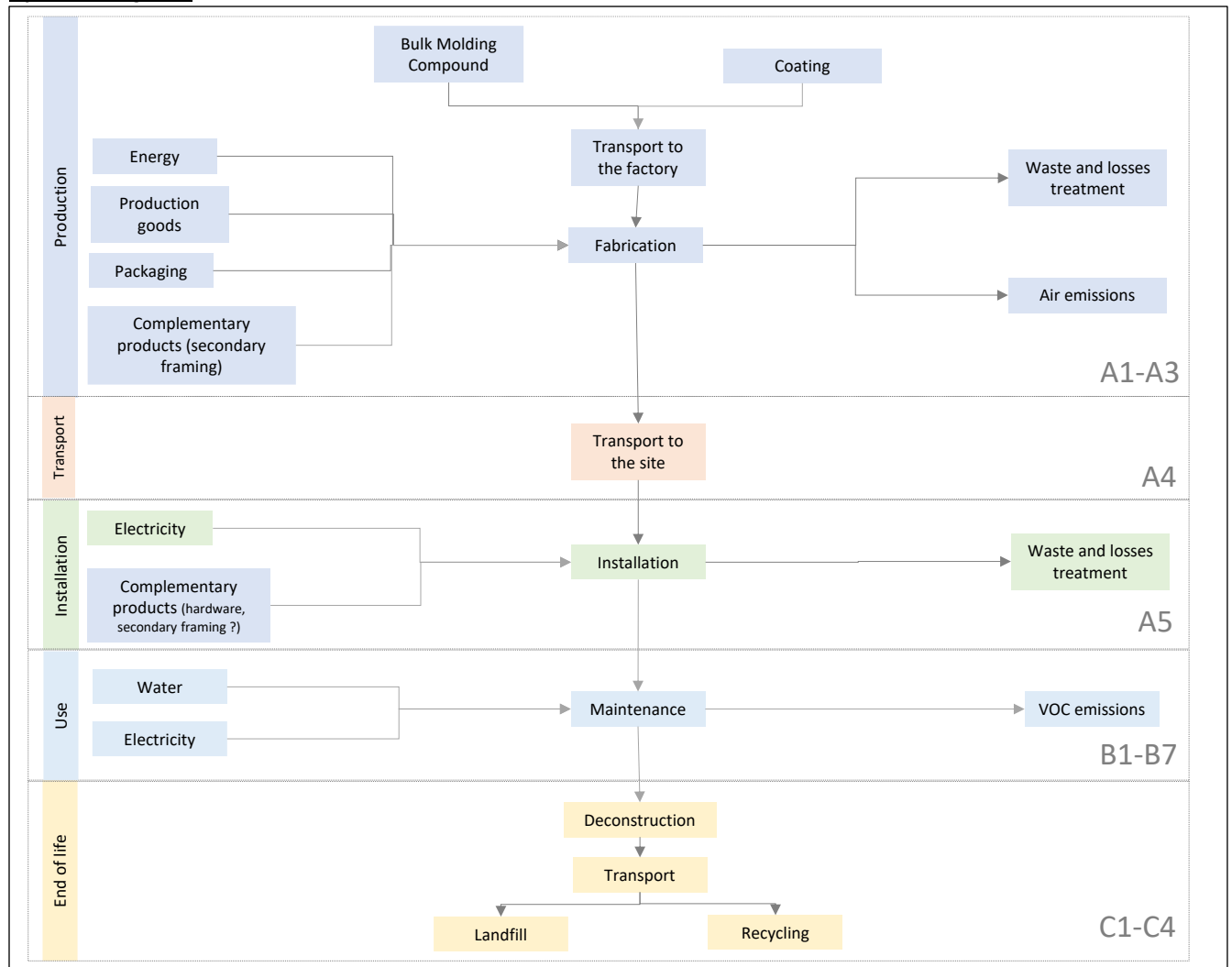

This EPD is also registered on the INIES database for the french market and under the same name.

Below is a description of the main hypothesis used to model the life cycle of the products.

- **Production stage, A1-A3 (production year: 2018)**

The steps from A1 to A3 include all the processes from raw material extraction to factory transformation. The panels are made with press according to the following steps:

- Casting of the BMC (Bulk Molding Compound)
- Press
- Surface treatment (coating application)

- **Construction process stage, A4-A5**

The product is delivered by a truck and boat from the factory to the construction site. The transport distance is an average distance of the deliveries made by CAREA in Great Britain, Ireland, Switzerland and Germany over the data collection period. In average, the products travel 920km by truck and 3km by boat.

The panel and the under-structure are set manually with an electric screwer. The energy consumption of a hoisting machine is also taken into account. Installation waste consists of packaging waste.

- **Use life stage (Exclusion of potential savings), B1-B7**

One product cleaning every 10 years is taken into account in accordance with the manufacturer's recommendations.

- **End of life, C1-C4**

At end of life, the product is disassembled by hand. Only electricity for an electric screwdriver is taken into account. Aluminium and steel from under-structure are recycled, at a rate of 90% and 83% respectively. Remainder is sent to landfill at 100%.

- **Benefits and loads beyond the product system boundary: module D**

Module D is applied to end-of-life aluminium for which there is a recycling market and well-established data. The percentage of recovered (or recycled) end-of-life aluminium is estimated at 90%. It is considered that recycled aluminium replaces primary aluminium of equal quality. The percentage of recycled aluminium entering the system is also considered in module D.

- **Variability**

The thickness of the declared product corresponds to the weighted average of sales between the "standard" version thickness and the "solid" version thickness. The "solid" product is only used for first floor facades and exposed to impacts, so it is less sold (about 7.4% of sales in 2018).

The thickness of the products is 4 or 5mm.

¹ It is chosen to declare the average product, which is representative of most CAREA sites despite a variation of more than 10%.

Indeed, for a given building site, two types of products are used: "standard" panels in the current part and "reinforced" panels only on the first floor of facades exposed to impacts (mainly on roads). This type of facade being limited on a building site (R+5 on average), the average product, constituted with 7,4% of "reinforced" panel, is estimated to correspond not only to the CAREA's sales but also to the very great majority of the building sites.
